# HEINEKEN LIGHT BURGER BEAST SWEEPSTAKES Full Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASING A PRODUCT WILL NOT IMPROVE YOUR CHANCES OF WINNING.

THE HEINEKEN LIGHT BURGER BEAST SWEEPSTAKES ("SWEEPSTAKES") IS OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES RESIDING IN THE COUNTIES OF MIAMI-DADE, BROWARD AND PALM BEACH WHO ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. ## 1. START/END DATES:

Sweepstakes begins at 12:01 a.m. Eastern Time (ET) on 1/20/17 and ends at 11:59 p.m. ET on 2/21/17 ("Sweepstakes Period"). This Sweepstakes is in no way sponsored, endorsed, or administered by, or associated with, Instagram, Twitter, or Facebook. You are providing your information to Heineken USA Inc. ("Sponsor").

## 2. HOW TO ENTER:

You can enter by uploading a photo of your favorite burger, and there are several different methods of entry as set forth below. The photo can be of a burger from your favorite burger place, or it can be your own creation. It should be submitted with the hashtag **#burgerbeastsweeps**.

- a. Internet Entry: To submit an Internet entry for free, visit www.burgerbeast.com and follow the on-screen entry instructions. You must fully complete the registration, including your first and last name, date of birth, street address (no P.O. Boxes), city, state, zip code, and daytime telephone number (including area code), and upload a photo of your favorite burger with the hashtag #burgerbeastsweeps. Normal time rates, if any, charged by Internet service provider will apply. All Internet entries must be submitted by 2/21/17.
- b. Instagram Method of Entry: During the Sweepstakes Period (defined above), access the Instagram application on your mobile device ("Mobile Device"), and upload the photo with the hashtag #burgerbeastsweeps. If you do not have the Instagram application, you may download it through the application store on your Mobile Device. The Instagram application is

free. Instagram's Terms of Use apply; visit <a href="http://instagram.com/legal/terms/">http://instagram.com/legal/terms/</a> for details. All Instagram entries must be submitted by 2/21/17.

c. Twitter Method of Entry: During the Sweepstakes Period (defined above), sign in to your Twitter account and upload the photo of your burger. If you do not have a Twitter account, you may create one by visiting <a href="www.twitter.com">www.twitter.com</a>. Twitter accounts are free, and Twitter's Terms of Service apply; for details, visit <a href="http://twitter.com/tos">http://twitter.com/tos</a>. You must be an active holder of a nonprivate Twitter account to be eligible to enter this Sweepstakes via Twitter (i.e., you must make sure your tweets are set to "public" and not "private"). Upload the photo from your Mobile Device or your computer using the hashtag #burgerbeastsweeps. All Twitter entries must be submitted by 2/21/17.

In the event of a dispute as to the authorized registrant of any Twitter account, the authorized account holder of the e-mail address used to register on the Twitter platform will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. **d. Facebook Method of Entry.** You may also enter on Facebook by going to https://www.facebook.com/HeinekenUSA and posting your photo with the hashtag **#burgerbeastsweeps**. All Facebook entries must be submitted by 2/21/17.

You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier.

**Photo Guidelines:** Photos must show the burger only. There may not be any identification of any retail licensee included in the photo.

By submitting an entry, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the judges, which will be final and binding in all matters relating to the Sweepstakes. Limit of one (1) entry per person regardless of method of entry. Please note that there is a limit of one (1) prize per individual, household, street address, and/or e-mail address during any six (6) month period across all HEINEKEN USA Inc. promotions, regardless of brand (Amstel, Buckler, Bohemia, Carta Blanca, Dos Equis,

Heineken, Indio, Tecate, Newcastle, Sol, and Strongbow).
